## New Phase of Cleaner Production Partnership Programme ( 2020-2025 )

**Demonstration project: Installation of automatic cleaning system replacing the manual cleaning of rubber blanket in printing process to save solvent and reduce volatile organic compounds (VOC) emissions**

### Background

In 2008, the HKSAR Government launched the Cleaner Production Partnership Programme (the Programme) to encourage and facilitate Hong Kong-owned factories in Hong Kong and Guangdong to adopt cleaner production technologies and practices, thereby contributing to improving the environment. In the light of the significant environmental benefits and positive industry response brought by the Programme, the HKSAR Government has extended the Programme until 2025 with an additional funding of HK\$311 million.
